ELA Item Alignment Modules User Guide

Overview:

The Item Alignment Modules are a set of professional development materials intended to provide users with a deep understanding of the expectations of high-quality ELA Literacy items aligned to the Common Core State Standards for Reading, through the lens of items resembling those used for summative assessments. These modules can serve as a resource for a variety of users and purposes. The table below provides some examples of potential uses, noting how the modules may need to be modified to suit specific purposes.

Please note: The table is not exhaustive, but it can serve as a reference as you consider how to best use these modules to suit your specific needs.

While the Grade-Specific Modules are developed with the CCSS in mind, the principles in the High-Quality Reading Items modules are based on Section B.3 of the CCSSO Criteria for Evaluating and Procuring High-Quality Assessments and can be used in states that use the Common Core State Standards as well as states that have created their own college- and career- readiness standards.
