

The Case for Teacher Leaders: Elevating the Teacher Profession and Sustaining Equity and Excellence

A new policy brief from Chiefs for Change —an independent nonprofit for district and state chiefs —outlines sustainable teacher leadership systems that could be facilitated under ESSA's Title II funding. According to Education Week, the brief states that "teachers should be empowered to create and sustain effective education policy; the state should build a culture of innovation (rather than allowing the red tape of bureaucracy to strangle any ideas that teachers have); and teacher leaders should be set up to address a specific challenge, rather than a vague leadership call to action."

"We set out to strengthen teacher content knowledge in mathematics. A success we had this year was successfully implementing an Intellectual Preparation Protocol in which teachers systematically analyzed standards, progressions, aspects of Rigor, and aligned tasks. Teachers used this knowledge to deliberately inform instructional decisions. Using the Instructional Practice Guide (Coaching Tool) as a calibrator, we saw an increase in proficiency of instructional decisions and teaching moves as the year progressed."




