Impact Through Instructional Advocacy: A Balanced Approach to Developing and Assessing Math Fact Fluency

Core Advocates Kristi Gettelman and Dani Palm shared valuable information at the May Core Advocates convening about developing and assessing fluency. They presented a three pronged approach including purposeful instruction, consistent practice opportunities, and

Using the Coherence Map

Have you heard about this great tool called the Coherence Map? Two Kentucky teachers have written a detailed **blog post** introducing the **Coherence Map** and explaining how it's been useful to them in their kindergarten math team. They call out two use cases in paticular: identifying targeted interventions for struggling students and helping teachers understand how the work in younger grades is part of the larger pathway to algebra. Text Set Resource!

Do you use Achieve the Core's text sets as a resource to build your students' knowledge? The Copyright Clearance Center recently partnered with Xanedu to make low cost versions of the student facing resources. On Achieve the Core, go to ELA lessons (under Classroom Resources). When you select "Text Set Project" from the left hand side, follow the "Option to Purchase Texts" link to let someone else do the work of photocopying text excerpts— and know that they are all permissioned and ready for student use!

Rigor Matters!

This **essay**, part of a series on personalized learning, was published in The Lens, the Center on Reinventing Public Education's (CPRE) blog at the University of Washington Bothell. It raises the question of how personalization can be effectively balanced with rigor and recommends two critical strategies for success: "start with standards, not structures" and "assess and discuss rigor". They go on to recommend using the Instructional Practice Guide as, "a flexible tool that teachers and leaders could use to help keep rigor part of the conversation as they reimagine a more personalized and engaged classroom for students."




